Starter Adapter Warranty

Each Overhauled Starter Adapter shipped from Canadian Aero Manufacturing is warranted as follows:

For a period of twelve (12) months from date of purchase or 200 hours from first use for any purpose, whichever comes first, after the warranty activation date. Canadian Aero Manufacturing (CAM) will, at its option, repair or replace any overhauled Starter Adapter which, within the applicable 12 months or 200 hours, is returned to CAM and which upon examination is found, to the satisfaction of CAM, to be defective in CAM supplied material or CAM workmanship. **The "warranty activation date" is the date of first use for any purpose OR 12 months following the date of sale as evidenced on the original CAM invoice, whichever occurs first.**

Repair or replacement of the Starter Adapter under this warranty will not extend the period of warranty coverage set forth above. CAM reserves the right at its option to replace any defective part or component with either a new or rebuilt part or component.

CAM does not assume responsibility for any labor or transportation costs in connection with the repair or replacement of any part or component under this warranty.

This warranty applies only to Starter Adapters properly installed following CAM instructions supplied with each overhauled adapter. The Starter Adapter must be inspected and maintained in accordance with the instructions for continued airworthiness including compliance with all applicable service bulletins issued by Continental and the aircraft manufacturer. Performance of recommended inspections and maintenance must be documented by proper logbook entries and a copy of the logbook must accompany any Starter Adapter being returned for warranty consideration.

This warranty does not apply to any Starter Adapter installed on an engine which;

- 1: has been subject to misuse, neglect, improper storage or accident,
- 2: has been installed, repaired, maintained or altered in any way that, in the judgment of CAM, has adversely affected the condition of the Starter Adapter,
- 3: has been operated inconsistent with Continental and aircraft manufacturer recommendations and limitations,
- 4: has been changed from its original FAA certified configuration.

CAM will not be responsible for repair or replacement of any Starter Adapter damaged or worn as a result of corrosion, pre-ignition, detonation, kickback, or damage resulting from the use of a geared, light weight starter, or starter that has not been overhauled at time of adapter installation, as detailed in the installation instructions supplied with each overhauled Starter Adapter.

The sole and exclusive remedy under this Warranty is limited to repair or replacement as specified elsewhere in this document. There are no other Warranties, expressed or implied. In no event will CAM be responsible for any incidental or consequential damages arising out of any defect in any part or component arising out of the failure of any part or component to operate properly or arising out of any breach of the warranty made herein.
